

## A Message From the President

The mission of the Osteogenesis Imperfecta Foundation is to improve lives. I am proud to report that the work we have accomplished during the last fiscal year reflects the steps we have made in fulfilling our commitment to you, the OI Foundation contributor and friend.

As you will read in the report, we have continued to focus our efforts in 2012 in the areas of improving the health of people living with OI, implementing coordinated research activities, supporting the OI community and increasing education and outreach.

In 2012 the OI Foundation hosted the biennial conference titled "Awareness, Advocacy, Action." The conference brought together more than 700 people from the OI community. Conference attendees attended workshops from OI specialists and had the opportunity to connect with old friends and make new ones as well. Prior to the start of the conference 105 people traveled to Capitol Hill and visited more than 40 congressional offices, giving legislators and their staff information about OI and our effort to increase OI research at the federal level.

The work of the Linked Clinical Research Centers continued and in 2012 enough data was collected to begin the work of publishing findings, facts and trends. The OI Foundation also continued funding two Michael Geisman Fellows through the research grant process and a clinical research grant was awarded to Dr. Jay Shapiro at Kennedy Krieger, which will hopefully lead to a better understanding of heart conditions in OI.



## Awareness

In May, the OI Foundation held its second National OI Awareness Week, involving volunteers across the country in holding awareness and fundraising events within their communities. Awareness Week 2013 will take place May 4-11, 2013, and on May 6, 2013, the Foundation will officially participate in Wishbone Day, an international awareness event that will help to raise awareness about OI all over the world! Awareness Week volunteers secured city and state proclamations declaring it OI Awareness Week, 15 new OI fundraising events were held and articles appeared in more than 15 newspapers around the country about OI.



## National Conference 2012



In July 2012, the OI Foundation held its biennial National Conference in Washington, DC. More than 700 people attended this conference themed "Awareness, Advocacy, Action!" Prior to the start of the conference, 105 people traveled to Capitol Hill for the OI Foundation's advocacy day and visited 40 congressional offices giving legislators and their staff information about OI and our effort to increase OI research at the NIH. The advocacy day kicked off with a presentation to Congressman "Dutch" Ruppersberger, D-MD – he was awarded the Advocacy Unbreakable Spirit™ Award for his effort in helping improve awareness about OI. Participants visited their legislators and in one special case were greeted by House of Representatives Speaker of the House, John Boehner.

The 2012 National Conference also presented the first Women's Forum coordinated by board members Michelle Duprey and Anna Curry Gualano. The forum, open only to women living with OI, explored issues that directly affect women including nutrition, sexuality, pregnancy and overall women's health. The forum was a success and will be repeated at the 2014 National Conference.

The conference included three days of sessions on topics ranging from home splinting to updates on the most current research being done in the field that may lead to improved treatments.

## Linked Clinical Research Centers (LCRC)

The OI Foundation, in partnership with the Children's Brittle Bone Foundation, continued funding five LCRCs and reached its enrollment goal of 500 people in the natural history study in 2011 and increased the number to 605 in 2012. Dr. Reid Sutton, the LCRC's project manager, released preliminary information on findings from the study and has submitted those findings for publication in scientific journals. Publication will take place in early 2013.

## Scientific Meetings

In April, 100 scientists gathered for the OIF annual scientific meeting in Chicago, IL. Dr. Laura Tosi chaired the meeting titled, *Assessing the Impact of Osteogenesis Imperfecta on Nonskeletal Systems*, which focused on the impact of abnormal collagen on health in an effort to broaden professional awareness of the full spectrum of issues faced by person living with OI as they age. A workshop report was compiled and submitted for review. This meeting was a continuation of the ANHI (Adult Natural History Initiative) addressing health concerns that were identified by more than 1100 adults living with OI who responded to a survey. The meeting will contribute to research that will enhance knowledge of the natural history of OI and lead to the development of educational resources for patients and providers that provide reliable, relevant and understandable information about treatment options and their risks and benefits. The conference was made possible by the generous support of the Buchbinder Family Foundation.

In September 2012, the OI Foundation took the lead role in presenting a scientific meeting focusing on rare bone diseases, including OI. The meeting titled *Rare Bone Disease Research Summit – Future Directions*, brought together the leaders in rare bone disease research and was chaired by Dr. Jay Shapiro of Kennedy Krieger in Baltimore, MD and a member of the OI Foundation's Medical Advisory Council. The meeting goals included presenting a status update on the most current rare bone disease research and developing strategies to accelerate such research in the future. Speaker abstracts were submitted to the journal *Seminars in Arthritis and Rheumatism* and were published in February 2013.

Additionally, Dr. Shapiro, on behalf of the OI Foundation, led a working group at the 2012 ASBMR (Association for Bone and Mineral Research) meeting in Minneapolis, MN. The working group focused on rare bone disease research and continued the discussion from the Research Summit on how to collaborate in an effort to accelerate rare bone disease research. Young investigators and senior scientists attended this "sold out" working group. Another working group will be held in 2013 and led by the OI Foundation.

## Research Grants

In 2012, the OI Foundation continued funding two Michael Geisman Research Fellowships to researchers at Children's Hospital in Boston and the University of Washington in Seattle. Each of these studies examines specific genetic mutations that may someday lead to new treatments to strengthen bones, once they are better understood. Both researchers have been successful in moving their research forward. Their reports will be available on the OIF website shortly. In addition, the OI Foundation funded a clinical research grant that will lead to a better understanding of heart conditions in OI including heart valve problems, problems with the aorta or other blood vessel problems. A greater understanding of heart surgery in OI patients and the results after heart surgery is an additional goal of this study. It is being conducted at the Kennedy Krieger Institute by principal investigator Dr. Jay Shapiro.

## Adult Natural History Initiative (ANHI)



The ANHI committee met at the 2012 OIF Annual Scientific Meeting

Work continued on the Adult Natural History Study with approximately 1100 adults living with OI completing the survey for this ambitious study, led by Dr. Laura Tosi of Children's National Medical Center in Washington, DC. ANHI uses an NIH-approved,

Internet-based questionnaire to collect information about participant's current health status, quality of life, and health concerns. Combining this information with the OI Registry and the Linked Clinical Research Centers will create a clearer description of the health needs of adults living with OI and identify areas needing research. Results from the survey were used to develop the agenda for the April 2012 scientific meeting.

## OI Registry

The OI Registry is a joint effort between the OI Foundation and the Kennedy Krieger Institute. Participants complete a profile of their medical characteristics, family history, fracture history, and treatment. Based on one's profile, people are contacted about institution and IRB-approved clinical research study opportunities. Since the Registry opened in March 2006, more than 1,500 people from the United States and 39 other countries have joined.

## Impact Grants

In partnership with the Children's Brittle Bone Foundation, 10 grants totaling \$131,000 were awarded to people living with OI in need of products or services that would improve the quality of their lives in 2012. Grantees received funds to purchase adapted vehicles, new mobility devices, computers, hearing aids, dental work and other products and services. A new cycle of funding began on January 1, 2013.

## OI National Information Center

Approximately 6,500 requests for information were provided during the year, and the OI Foundation website was visited 205,000 times in search of information. The Center also offers a variety of resources, many of which can be downloaded free of charge on [www.oif.org](http://www.oif.org), including booklets, brochures and more than 70 fact sheets.

## Social Networking

The OI Foundation manages four social networking sites — Osteogenesis Imperfecta (OI) Foundation Facebook Page, NING, OI Foundation Twitter, and Sunday Night Chat. The OI Foundation continues to offer on [www.oif.org](http://www.oif.org) links to other social networking sites that might be helpful or interesting to parents and young people living with OI. The additional sites are managed by volunteers that the Foundation has established a working relationship with.

## Advocacy



Volunteers and staff continued to educate legislators and key decision makers on the importance of increasing bone research at the NIH and other agencies.




